Dear Mr Howarth,

I am sending you this now---- many years ago I came to you for help and I asked you to take the case to the parliamentary ombudsman you did not do this and my son suffered gretly and will suffer for the rest of his life he will never be free , unlike the alleged abusers who are free to this day. As his PTSD was included in his Educational Statement a legal document in 2000 the local authority now cannot ignore that Adam had suffered PTSD , they tried to blame us but closed the case in 2000, we believe it was not closed and the data protection act was breached when certain data was sent to Southampton City Council --alleged We demand a full investigation into the whole affair and we request that you help us in that quest we have complained to operation yewtree. are you again going to say NO alleged.

Dear Sir or Madam,

You will find contained in this Email a formal complaint sent to Southampton City Council, as it involves we believe your council we are sending it to you, we have already asked Southampton to inform you of our complaint.

Mr Adam Stewart and his family allege the following;-----

- * Breach in the Human Rights Act.***
- * Breach in the data protection Act--(gave Southampton City Council data (selected) on Adam Stewart and his family, without their written consent to data being exchanged.***
- * Breach in the Freedom of Information Act***
- * Breach in the Vulnerable Persons Act***
- * Breach in the Equallity Act***
- * Dicrimination Act***
- * Breach in their duty of care***
- * Were offered everything by Social Services if we signed the 17/47 when we did not sign we got nothing-eg- no respite care for one.***
- * We were not told by Social Services that if we had signed the 17/47 the children would have been in care the next day. Did they lie when they promised us every thing???? We were told this in August 2000 in Aldershot by M.***
- * Allege--did not transfere blue badge from Hampshire to Southampton as Southampton refused to give Adam the blue badge that he had in Farnborough from Aldershot Social Services.***
- * Abuse (physical)gouge marks on body that were there for 5 weeks photos taken) on a vulnerable child over a 3/4 year period between 2 schools and one community centre;--- original abuse (physical) at OAK FARM SCHOOL, FARNBOROUGH, HAMPSHIRE.(WHICH***

WE ALLEGE CONTINUED UNTIL HE WENT TO SAMUAL CODY SCHOOL, ALDERSHOT HAMPSHIRE, WHERE IT CONTINUED UNTIL HE LEFT TO GO TO THE MEDOWS SCHOOL, BORDEN HAMPSHIRE WHERE HE THEN RECIEVED PSYCHIATRIC HELP HAD A GOOD HEADMASTER , WHICH THE FAMILY WORKED WELL WITH, UNTIL HE LEFT SCHOOL AND MOVED TO SPAIN FOR HIS SISTERS HEALTH.(SHE HAS IMMUNE DEFICIENCY A LIFE THREATENING CONDITION HER CONSULTANT RECOMENDED A HOT COUNTRY OR HER LIFE EXPECTENCY WOULD BE 21 YEARS SHE IS NOW 24 YEARS.)

*** The alleged abuse at Aldershot community centre happened once , Adam never went back mark on nose photo taken. Adam all through the years has maintained 4 people have abused him he has told the police, drs, teachers, social workers Education Authority).all who had a duty of care, We believe no one wanted to hear him or help him ,yet it is in all social services documents (diane S.W.wrote it down) This point was rased at the social services tribunal in 2000 the chairman of the council could not understand who or why the 17/47 had been carried out wihout a multi agancy meeting ? He said he was nor happy that a joint investigation had not been undertaken at the beginning between the police and social services as it should have been . He also said on the evidence before him (some was missing especially the evidece where the social services said that adam had been abused at the school and adam had told them who the 4 people were.) that abuse may have occured at the school and he directed social services to investigate (i have been told since that all they did was phone the school and ask if anyone had abused Adam , the school said NO so no further action was taken---- is this correct, if so you have breached the Equality Act , you alleged abuse of Mr and Mrs Stewart and you did a 17/47. It stands to reason that a 17/47 should have been undertaken against,--- Penny/Margaret(Oak Farm School) helpers /Mr Beven(headmaster) Mr Jones (adams teacher at the time) Samuel Cody School , Aldershot) THAT WOULD HAVE BEEN EQUAL TREATMENT. If you cannot show me proof of this or the actions taken against these people then i have to conclude that the Equality Act has been breached.**

Alleded victimisation/vendetta ,-- we believe it is because we won 4 tribunals, the last containing his PTSD.and one social services tribunal that we had to fight for over a 5 year period + the fact that I Mrs Stewart did not sign the 17/47 because i believed that it contained lies about me which started with a falsified document , nothing was told about both schools or the community centre , although the 17/47 was closed in 2000 . we allege it has been given to Southampton city council + certain evidence to further the alleged vendetta across the years. I have always maintained our innocence, for years in documentation we requested you to take us to court then i would bring the person who told us you were going to produce the false evidence against us and see who the judge believed (I allege you never did it was because the 17/47 was not carried in the correct way and the Social services chairman high lighted this.

Mr Adam Stewart and his family believe and allege that Hampshire County Council , breached certain acts and failed in their duty of care to a young vulnerable person , (allege).

we also allege that because Mrs Stewart was trying to find out where to get care and who had abused her son, Adam, a 17/47 by Aldershot Social Services was started against her on false evidence given in a letter from the Education dept in Fleet , I was told it was a lady officer . (before it happened i was told it was going to happen by hm.)(the same lady officer at a educational tribunal in 2000 said i was a wonderful mother we had just won the tribunal

and got Adams post traumatic stress disorder into his educational statement.why would she say in a letter i was a bad mother then years later say i was good . until proven this is alleged.

By starting the 17/47 on Mrs Stewart it prevented her from seeking the help she needed for her son , sh eventually got that help from GOSH and the Medows School at Borden , but by then Adams PTSD remained untreated , even after a private consultants report in 1997 was given to Hampshire County Council it was not until the educational tribunal in 2000 that the PTSD was entered into his Educational Statement a legal document , from then his PTSD could not be ignored or brushed under any carpets as I allege the Hampshire County Council tried to do. That evidence was present at the last Tribunal when we managed to get Adam away from Samuel Cody school into the Medows. ,it was not backed up by another psychiatrists evidence until 2000. Even so the Judge asked Hampshire County Council asked the following question ;-----

"You had this 1997 psychiatrists report in 1997 then Dr Glazers (GOSH) in 2000 and you still did nothing?"

Under the Freedom of Information Act, I request ALL !!!!! documentation from 1995/2000 from ;---

- * ST JOHN FISHER SCHOOL (IT SHOWS WHO WELL ADAM DID BEFORE THE ALLEGED ABUSE, HE NEVER TRIED TO RUN AWAY FROM THERE AS HE DID CONTINUALLY AFTER THE ABUSE ALLEGED IN BOTH OAK FARM AND SAMUEL CODY--WHY DID HE KEEP RUNING AWAY ? WAS IT BECAUSE HE WAS AFRAID OF MORE ALLEGED ABUSE.?????????????)**
- * ALL NOTES, LETTERS, TRIBUNAL DOCUMENTS FROM SOCIAL SERVICES AND EDUCATION ,ESPECIALLY THE ALLEGED FALSE LETTER WRITTEN BY THE EDUCATION LADY AND THE EVIDENCE THAT WAS READ TO ME OVER THE PHONE BY THE HEAD OF SOCIAL SERVICES STATING THAT ADAM HAD BEEN ABUSED AT THE SCHOOLS, THIS WAS MISSING AT THE SOCIAL SERVICES TRIBUNAL-- WHY .**
- * ANY EVIDENCE BETWEEN BOTH SOUTHAMPTON AND HAMPSHIRE COUNCILS 2013/2014**
- * ANY EVIDENCE CONTAINING ADAMS NAME OR OURS**
- * ANY EVIDENCE SAYING THAT THE 17/47 HAD BEEN CARRIED IN THE PROPER WAY ,AS THE CHAIRMAN THOUGHT IT HAD NOT.**
- * ANY EVIDENCE THAT YOU CARRIED OUT AN INVESTIGATION ABOUT ABUSE AT OAK FARM SCHOOL AND SAMUEL CODY SCHOOL AND THE OUTCOME.**
- *ALL OTHER EVIDENCE.**

WE HAVE COMPLAINED TO OPERATION YEWTREE, SCOTLAND YARD. ADAM HAS WRITTEN A COMPLAINT LETTER SAYING HE WANTS TO GO INTO COURT AND ASK THE JUDGE "FOR HIS LIFE BACK". WE WILL BE REQUESTING COMPENSATION, FOR THE HELL WE ALLEGE ADAM WENT THROUGH AND IS STILL GOING THROUGH HE NOW HAS ;---

PSTD, OBSESSONAL DISORDER DEPRESION AND ANXIETY DISORDER. WE BELIEVE IF HE HAD BEEN TREATED AT THE BEGINNING WHEN THE FIRST ALLEGED ABUSE OCCURED AND HAD THE CONTINUED GRABBING OF HIM WHEN HE TRIED TO RUN AWAY FROM FURTHER ALLEGED ABUSE , MAYBE ADAM WOULD NOT HAVE SUFFERED THE OTHER DISORDERS.

*** ADAM DID NOT DESERVE TO SUFFER PTSD, ANXIETY DISORDER,OBSESSONAL DISORDER ,DEPRESSION.**

*** HE DOES DESERVE TO BE TO BE BELIEVED**

*** HE DOES DESERVE HIS HUMAN RIGHTS**

*** HE DOES DESEVE EQUAL TREATMENT**

*** HE DOES DESERVE AN INVESTIGATIONS**

*** AS ADAM SAYS HE HAS RIGHTS , " MAM WHEN I AM BAD I GET TOLD OFF , THOSE PEOPLE HURT ME VERY VERT MUCH WHO TELLS THEM OFF" DO YOU TELL THEM OFF OR THE COURTS????????????**

THIS NEEDS TO BE INVESTIGATED AND OUR ALLIGATIONS PROVED RIGHT.
